Information

1. Apply Online:

Candidate has to apply online on the website.

(URL <https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>)

2. Application Form Fee:

- **₹413 (₹350/- + 18% GST [non-refundable])** for the candidate appeared in 12th board examination from the school located in the State of Gujarat (including Daman and Diu or Dadra Nagar Haveli (UT)).
- **₹1416 (₹1200/- + 18% GST [non-refundable])** for the candidate appeared in 12th board examination from the school located outside the State of Gujarat (including Daman and Diu or Dadra Nagar Haveli (UT)).

Note:- If any candidate of outside the state of Gujarat and paid the application form fee **₹413 (₹350/- + 18% GST)**, his/her application form will be disqualified.

3. Mode of Payment:

Payment will be made online through **Credit Card / Debit Card/ Net Banking**. Your application will be treated as complete only after the successful payment of an application fee and allotment of registration number.

4. Institute timings:

- **Monday to Friday and Odd-Saturdays** : 11.00 a.m. to 4.00 p.m.

Admission Rules

The 35% seats of intake shall be filled by Institute of Technology, Nirma University under the category of All India seats from the candidates who have passed the qualifying examination from the schools located in India (including Gujarat State).

1. Eligibility:

1. Candidate must have appeared in Paper – I of JEE (Main)-2020.
2. Candidate must have passed 12th Science Examination with Physics and Mathematics with (Chemistry or Biology or Computer or Vocational Subject) from single board with the percentage of marks as to be decided by the Government of Gujarat (GoG) under the rules of admission.

2. Mode of Admission:

1. These seats shall be filled-in by the candidates who have passed 12th Science Examination with above mentioned subjects from the school located in India (including Gujarat State) on the basis of All India Rank (AIR) in Paper – I of JEE (Main)-2020.

2. Online application form is available on the website (URL <https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>) and same should be filled with correct information (as per the instruction) and make payment by **Net banking / Credit card / Debit card.**
3. The provisional merit list with detailed programme of counselling will be displayed on website (URL <https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>).
4. The filled application form (online), Score card of JEE (Main)-2020 and Mark Sheet(s) of HSC (Std. 12th) examination need not to be sent to the Institute.
5. In case, Letter Grade / Performance Index or Graded Point Average is awarded, instead of percentage marks/percentile in qualifying examination, equivalence certificate from school authorities shall be required on the day of counselling of admission.
6. Online counselling will be carried out as per the schedule for the admission to First Year B.Tech. Programme 2020. Allotted admission seat of the candidate will be confirmed only after the successful payment of necessary fees, subject to verification of Eligibility and necessary documents.
7. The candidate has to report for document verification within stipulated time as per the schedule at Institute of Technology, Nirma University, Ahmedabad along with following documents (original and two sets of photo copies) and two passport size photographs.
 - a. SSC (Std. 10th) Examination Mark Sheet
 - b. HSC (Std. 12th) Examination Mark Sheet
 - c. School Leaving Certificate / Transfer Certificate
 - d. Admit Card of JEE (Main)-2020 (whichever is applicable)
 - e. Rank Card of JEE (Main)-2020
 - f. Equivalence Certificate (In case, Letter Grades / Performance Index or Grade Point Average awarded in qualifying examination)
 - g. Receipt of online payment of fees.

8. If required, Offline (In-person) counseling will be carried out as per the schedule for the admission to First Year B.Tech. Programme 2020. The candidate has to report within stipulated time as per the schedule at Institute of Technology, Nirma University, Ahmedabad along with the documents mentioned in Point No. 7.
9. Candidate is required to follow admission procedure and schedule, declared time to time at the office of the Institute and website (URL <https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>).

3. Reservation of Seats:

- a) For the purpose of admission, the seats shall be reserved for the candidates who are of Gujarat Origin and falling under the following categories and in following proportion, namely:

i. Scheduled Caste (SC) : 7 %

ii. Scheduled Tribes (ST) : 15%

- b) A candidate seeking admission on reserved seat shall be required to produce a Certificate of Caste from the competent authority of Government of Gujarat.
- c) No caste certificate shall be valid unless it is duly stamped, signed and issued by the authority empowered by the Government of Gujarat.
- d) If a candidate fails to submit the necessary caste certificate as required within the stipulated time, his candidature shall be considered for admission under unreserved category as per open merit.
- e) If a candidate of reserved category gets admission on unreserved seats in order of open merits, he/she may be given admission on the unreserved seat according to his/her preference, subject to fulfillment of open category eligibility criteria and as per merit order of open category merit list.
- f) The admission of a candidate of a reserved category on a reserved seat shall be valid subject to the verification of caste certificate issued to him/her by the authority empowered by the Government of Gujarat in this behalf. In case, the caste certificate is found to be invalid on

verification, he/she shall not have the right to claim his/her admission on reserved seat and if he/she has already been granted admission, such admission shall be cancelled.

- g) Reserved seats remaining vacant in any of the afore-mentioned categories shall be converted to open category seats.
- h) The merit list of the SC/ST categories will be prepared based on the All India Rank (SC/ST Category Rank) of Paper – I of JEE (Main) – 2020 Entrance Examination.

4. Preparation of Merit List:

The merit list will be prepared based on the All India Rank (CRL Rank) of Paper – I of JEE (Main) – 2020 Entrance Examination declared by NTA.

5. Counselling Process

1. Candidate has to fill up the branch choices, at the time of filling up the application form, online on the website (URL <https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>).
2. The filled branch choices can be modified up to **the last date**. Branch choices will be locked automatically on the last date.
3. As per the locked choices, admission committee will proceed one or more online rounds for allotting the seats and declare the status of allotment on website (URL <https://technology.nirmauni.ac.in/admission-aid/under-graduate/b-tech/>). The candidates may view their status of allotment by login to their account.
4. After each online allotment, following four options will be given to the selected (on the basis of merit) candidates in their accounts and they are required to select any one out of these four options, failing within stipulated time duration his / her candidature deemed to be cancelled.

Option A. I accept the branch allotted to me and I do not want any up-gradation in branch allotted. I will pay the required fees within the time limit. I will also report to the Nirma University as per the given schedule. Failing which I will not have any right for admission to Institute of Technology, Nirma University.

Option B. I accept the branch allotted to me and I will pay the required fees within the time limit, however I want to remain in counseling process for branch up-gradation. Branch up-graded as a result of reshuffling will supersede the current branch allotted and binding to me. I will also report to the Institute of Technology, Nirma University as per the given schedule. Failing which I will not have any right for admission in the branch made available to me at Institute of Technology, Nirma University.

Option C. I am not interested in allotted branch but I want to remain in counselling process for branch up-gradation.

Option D. I am not interested in branch made available to me as well as I do not want to remain in counselling process for branch up-gradation. (As soon as candidate selects this option, he/she will be out of counselling process at Institute of Technology, Nirma University).

Note:

- 1. If you select Option A or Option B, it is mandatory to deposit the required amount of fees through online mode immediately and enter the required details of payment.**
- 2. If you fail to deposit the fees in stipulated time duration, your admission is liable to be cancelled and you will be out of the counselling process.**
- 3. If candidate does not choose any of the above options within stipulated time duration, Option 'D' will be considered by default.**
5. The candidate who has secured an admission at Institute of Technology, Nirma University by paying requisite fees will get information letter containing check list of the documents to be submitted. Candidate along with only one Parent have to report with print out of the information letter and necessary documents (original along with two sets of photocopies and two passport size photograph) for verification and to prove eligibility of the candidate on notified schedule. Failing to report on notified date, will lead to cancellation of candidature.
6. If candidate has already taken admission to B. Tech Programmes at Institute of Technology, Nirma University by online counseling, have to remain present in-person for branch up-gradation in subsequent round of counseling.

7. If candidate is unable to remain present In-person for document veification, due to unavoidable circumstances, parent with authority letter from candidate will be permitted, provided the admission committee is satisfied for the genuineness about the candidate's inability to remain present.
8. If candidate does not remain present at the scheduled date and time and presents himself afterwards, he/she will be offered admission in the branch available at that time.
9. Candidate can cancel his/her admission through online cancellation module available in his/her login. Candidate has to submit the original fees paid receipts as well as admission order along with the print-out of cancellation request within one week to the Institute either through post/courier or come personally. **Failing to do so, the refund process will not start.**

Candidates are advised to visit website regularly for updates related to counselling process.

5. Refund Policy:

Sr. No.	Details
1	If a candidate withdraws the admission up to <u>the last date</u> , the fees paid shall be refunded (by deducting <u>Rs.1,000/-</u> as administration charges) after 15 working days from the cancellation date.
2	If a candidate withdraws the admission after <u>the last date</u> , but before the completion of the admission process at Institute, the fees paid shall be refunded (by deducting <u>Rs.1,000/-</u> as administration charges), <u>subject to the condition of such vacated seat being filled up by the Institution from the candidate of respective category</u> , after 15 working days of the completion of the whole admission process at Institute as per the directions of Admission Committee (ACPC).
3	If a candidate withdraws the admission after the closure date of admission under All India Category at the Institute, <u>the fees paid shall not be refunded.</u>
